- NEET UG score card.
- 10+2 marks card
- State Subject
- Category certificate wherever required.
- Date of birth certificate (Matriculation).

**IMPORTANT**

Subject: Tentative Seniority list of Computer Operators/Junior Assistant / Orderlies.

#### CIRCULAR DATED: 07.06.2018

Whereas, the J&K PSC officials repeatedly request for their promotion but their seniority has not been settled and is pending; and

Whereas, while examining the issue, it was noticed that there are no Recruitment Rules or a separate cadre for JKPSC. However creation have been made from time to time for different category/posts in the J&K Public Service Commission; and

Whereas, General Administration Department used to conduct the type test of eligible Class-IV employees of the Commission alongwith such employees of GAD and based on the results of the test, considered them for promotion in the ministerial cadre. This practice has been discontinued for about a decade now and with the result the Class-IV employees of the Commission are deprived of the only opportunity of career progression. Relief was provided to them by the Commission in 2010 when few such eligible matriculate Class - IV employees were placed in the ministerial cadre by way of one time exception; and

Whereas, the procedure for qualifying the test as mandatory for the promotion of orderlies to Junior Assistants have halted due to discontinuation, thus drawn a line of separation between Secretariat Cadre and JKPSC; and

Whereas, the Commission in its meeting held on 7<sup>th</sup> April 2010 regularized six orderlies as Junior Assistants against the posts held by them vide Order No. 139-PSC of 2010 dated 07.04.2010 as one time exception. This have paved way of separate cadre for the JKPSC employees; and

Whereas, the officials are neither in the seniority list of GAD nor JKPSC have notified any seniority till date; and

Whereas, the matter was placed before the committee constituted vide Order No. 241-PSC of 2017 dated 29.11.2017 to look into various issues viz promotion, insitu promotion and regularization of employee of the Commission which was held on 22.12.2017. The committee took various decisions , amongst other decision, the decision with regard to promotion /placements of Orderlies, Jamadars, and Jr. Assistants of the Commission is reproduced as under :-

**"The Committee decided that a tentative seniority of all the categories may be issued for inviting objections if any, within a period of 10 days. After that a final seniority may be issued and the case(s) for promotion /placement of these categories be decided.**

**It was also decided that finalization of J&K Public Service Commission (Subordinate) Recruitment Rules, the Commission may adopt J&K Civil Secretariat (Subordinate) Recruitment Rules for promotion /placement of non-gazetted cadre of the Commission.**

Whereas before the matter is placed before the Commission subject to fulfilment of the conditions prescribed under Rules proposed to be adopted, the seniority in all cadres/categories is required to be finalized; and

Whereas it have necessitated to issue a tentative seniority list of Junior Stenographer, Computer Operators, Junior Assistants, Jamadar-I&II /Packers/Orderlies/Safaiwalla/Ward and Ward of Public Service Commission; and

Now, therefore, the Tentative Seniority list of Junior Stenographer, Computer Operators, Junior Assistant and Jamadar-I&II /Packers/Orderlies/Safaiwalla/Ward and Ward forming Annexure A, B, C & D is hereby notified for information of all the concerned Officials having any objection in the tentative seniority list shall file their objections within a period of 10 days from the date of issue of the list.

Whereas, the Commission notified the posts of Lecturer (10+2) Geology vide Notification No. 09-PSC(DR-P) of 2016 dated: 19.03.2016; and

Whereas, in response to the said Notification, 327 applications were received out of which 103 applications pertained to the candidates who possessed post graduation degree in Applied Geology; and

Whereas, pending decision of the Commission regarding eligibility or otherwise of the candidates with Post Graduate Degree in Applied Geology, 48 candidates out of these 83 candidates who appeared were allowed to sit in the written examination; and

Whereas, subsequently the issue was considered by the Commission in its 21<sup>st</sup> Extra Ordinary Commission meeting dated: 06.06.2018 wherein it was decided to shortlist only those candidates for viva-voce who possessed the prescribed qualification for the post Lecturer in Geology, in terms of relevant recruitment rules prescribed by the School Education Department.

Whereas, in pursuance of the above decision, the candidature of all the 83 candidates with post graduate in Applied Geology, irrespective of the fact whether they appeared in the written test or not or were allowed to sit in the examination, is hereby rejected.

Now therefore, as per Rule 32 of J&K Public Service Commission (Conduct of Examinations) Rules, 2005 read with Rule 40 of J&K Public Service Commission (Business & Procedure) Rules, 1980, the candidates as per Annexure-A to this notification are hereby declared to have qualified for the Oral Test/Viva Voce for the posts of Lecturer (10+2) Geology in the School Education Department on the basis of their performance in the Written Test which was held on 28.04.2018. **The notification with respect to the dates of Interview/Viva-Voce shall be notified by or before 25<sup>th</sup> of June, 2018.**

Whereas, the Commission notified the posts of Lecturer (10+2) Geology vide Notification No. 09-PSC(DR-P) of 2016 dated: 19.03.2016; and

Whereas, in response to the said Notification, 327 applications were received out of which 103 applications pertained to the candidates who possessed post graduation degree in Applied Geology; and

Whereas, pending decision of the Commission regarding eligibility or otherwise of the candidates with Post Graduate Degree in Applied Geology, 48 candidates out of these 83 candidates who appeared were allowed to sit in the written examination; and

Whereas, subsequently the issue was considered by the Commission in its 21<sup>st</sup> Extra Ordinary Commission meeting dated: 06.06.2018 wherein it was decided to shortlist only those candidates for viva-voce who possessed the prescribed qualification for the post Lecturer in Geology, in terms of relevant recruitment rules prescribed by the School Education Department.

Whereas, in pursuance of the above decision, the candidature of all the 83 candidates with post graduate in Applied Geology, irrespective of the fact whether they appeared in the written test or not or were allowed to sit in the examination, is hereby rejected.

Now therefore, as per Rule 32 of J&K Public Service Commission (Conduct of Examinations) Rules, 2005 read with Rule 40 of J&K Public Service Commission (Business & Procedure) Rules, 1980, the candidates as per Annexure-A to this notification are hereby declared to have qualified for the Oral Test/Viva Voce for the posts of Lecturer (10+2) Geology in the School Education Department on the basis of their performance in the Written Test which was held on 28.04.2018. **The notification with respect to the dates of Interview/Viva-Voce shall be notified by or before 25<sup>th</sup> of June, 2018.**

- The candidature of candidates shown in Annexure -A is purely provisional.
- Only eligible candidates, possessing requisite qualification prescribed under rules, shall be allowed to appear in the Oral Test/Viva-Voce subject to the condition that they are within the prescribed age limit on the cut-off date.
