

Karna bypolls: Congress storms JDS bastion, wins two LS seats

BANGALORE, Aug 24: Striking a heavy blow to the JDS in its heartland, the ruling Congress in Karnataka today wrested the Mandya and Bangalore Rural Lok Sabha seats from it with impressive margins in the fiercely fought bypolls.

Multi-lingual actress Ramya on her electoral debut defeated C S Puttaraju of JDS in Mandya, the nucleus of his party's Vokkaliga vote base, by a margin of 67,611 votes, officials said.

In Bangalore Rural, it was a spectacular victory for Congress and heart-breaking defeat for JDS as former Chief Minister H D Kumaraswamy's wife Anitha Kumaraswamy lost by a huge margin of over 1.37 lakh votes to ruling party's D K Suresh, brother of state party leader D.K. Shivakumar.

Kumaraswamy, son of former Prime Minister H D Deve Gowda, had held the Bangalore Rural seat before he gave it up after winning the May Assembly polls and the Gowda family had invested all its prestige into the battle. He had won the seat by over 1.3 lakh votes in the 2009 Lok Sabha elections.

JDS had struck an understanding with the BJP which did not field candidates in both the constituencies where it winds no significant electoral influence.

Electoral officials said Suresh polled 5,78,608 votes against Anitha Kumaraswamy's 4,41,601 votes. In Mandya, Ramya secured 4,84,085 votes against her oppo-

ment's 4,16,474 votes. The poll outcome comes to the Congress just days after it celebrated 100 days in office still euphoric over its spectacular victory in the May Assembly polls that catapulted it to power with absolute majority, unseating BJP.

For Chief Minister Siddaramaiah, the result has come as a big boost to consolidate his position as an adverse outcome would have given a handle to a section of his own partymen not happy with his style of functioning.

The August 21 bypoll had also almost turned into an arena for scoring personal points for both Siddaramaiah and Kumaraswamy who made no-holds-barred attack against each other.

Siddaramaiah said JDS had been taught a lesson by voters who also saw through the JDS' alliance with BJP and KJP of former Chief Minister B S Yeddyurappa.

In an immediate fallout, Kumaraswamy met Deve Gowda and conveyed his decision to step down as state unit chief and as opposition leader in the Assembly. "I underwent a cardiac surgery and maybe, the voters thought I need rest," he was quoted as saying emotionally by a party release.

Both Ramya and Suresh maintained convincing leads right from the beginning as the counting of votes for the by-polls was taken up this morning and gradually increased the lead to unassailable levels. (PTI)

Musharraf's trial in murder case to be held in Balochistan

ISLAMABAD, Aug 24: The trial of former Pakistani military ruler Pervez Musharraf for alleged involvement in the killing of nationalist leader Akbar Bugti will be held in Balochistan and not the national capital, a court ruled today.

The Balochistan government has withdrawn a petition seeking the transfer of the murder case to Islamabad, TV news channels reported. A two-judge bench of the Balochistan High Court was hearing the case in which Musharraf is named as an accused.

During the proceedings, an Assistant Advocate General told the court the provincial government will provide complete security to Musharraf, currently being held at his farmhouse in Islamabad.

Musharraf's lawyer argued that blasts had occurred in the same area in Balochistan a few days ago, due to which security concerns exist for his client.

Responding to Musharraf's counsel, Balochistan High Court Chief Justice Qazi Faez Isa questioned whether the federal government had stopped functioning after the suicide attack on the Marriott Hotel in Islamabad.

The court then disposed of the case after the provincial government retracted its request to transfer the case to Islamabad. Baloch leader Akbar Bugti was killed in a military operation in Balochistan in 2006 when Musharraf was the President and army chief. Musharraf is facing charges in several high-profile cases, including the Benazir Bhutto assassination case. His farmhouse on the outskirts of Islamabad has been declared a "sub-jail" for security concerns. (PTI)

AP: New-born baby weighs 5.5 kgs

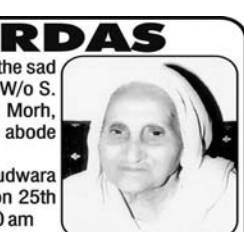
RAJAHMUNDRY, AP, Aug 24: A 20-year-old woman gave birth to a baby girl weighing 5.5 kgs at the GSL General Hospital here yesterday. "The average birth-weight is around 2.8 kgs. It is not unusual to be born with 2.5 to 3.5 kgs weight, but a baby with 5.5 kgs is quite unusual, especially in India," said Dr V Sarojini, Professor of Gynaecology and Obstetrics, GSL General Hospital. Both the baby and the mother were doing well, she added. The highest birth-weight in the world has been reported in Lybia (6.2 kgs). Karimi Devi (20), the woman, hails from Pera Ramachandrapuram near Anaparthi in East Godavari District. (PTI)
