

Mumbai gangrape victim discharged from hospital

MUMBAI, Aug 28:

The 23-year-old photojournalist, who was gangraped at a defunct mill complex here nearly a week ago, has been discharged from hospital after doctors attending on her declared her "medically fit".

"The patient had improved steadily and our team of doctors specially assigned, had declared the patient medically fit for discharge last evening and hence she was discharged late last night," said a statement from Jaslok Hospital, where she was admitted after the assault.

"Best quality medical care was given to the patient at all times at the hospital," it said, and thanked the authorities for the support.

The statement was issued by Dr Tarang Gianchandani, acting CEO and Director, Medical Services of Jaslok.

The hospital had recently announced that the young scribe was undergoing psychological counselling sessions.

The victim, an intern with an English magazine, was gangraped by five men on August 22 when she and her male colleague had gone to the deserted mill compound in Lower Parel on an assignment.

The incident triggered outrage across the country and was condemned as despicable and shameful stirring memories of a similar attack last December in New Delhi that sparked nationwide protests.

As people from all walks of life voiced their anguish, political parties, media associations and Bollywood were one demanding harshest punishment for the perpetrators of the crime in Mumbai which is seen as much far safer for women than others cities. (PTI)

PM should step down if he cannot stop rupee's slide: BJP

NEW DELHI, Aug 28:

With the rupee going downhill, BJP today said bankruptcy of ideas and indecisiveness of Congress-led UPA government is responsible for it and demanded that economist Prime Minister Manmohan Singh step down if he cannot stop the slide.

"Manmohan Singh became the Finance Minister and later the Prime Minister of this country due to his reputation of being a great economist. If he cannot control the slide of the Rupee or improve the state of the economy then he has no right to continue in office and should step down," BJP spokesperson Shah Nawaz Hussain said.

Another party spokesperson

son Prakash Javadekar blamed the fall of the rupee against the US dollar on "complete bankruptcy of ideas, indecision and non-governance of the UPA government".

"Manmohan Singh and his team of ministers are clearly to be blamed and must own responsibility. If the government would have taken timely action on the import-export front and would have done massive public investment in infrastructure, the health of the economy would have been better," he said.

Citing the example of Mexico and other countries which faced a similar challenge, Javadekar said they showcased how they could stabilise their currency with a major push of reforms. This helped them withstand the pressure created by the sudden outflow of FIIs.

"The country and its people will have to pay for the follies of this government. There will be all round price rise and millions will lose jobs and the common man will suffer. It is the non-governance of the UPA which is responsible for the crisis," he said.

The BJP leader charged that the government is clueless and the economic situation has gone out of hand. (PTI)
