

HC stays contract for public toilets at Kathua

JAMMU, June 20: State High Court today stayed the contract for construction and maintenance of public toilets at various places in Kathua for a period of 30 years.

The direction has been passed in a petition filed by an NGO namely Akhil Bhartiya Paryavaran Ewam, Patna challenging the agreement dated February 4, 2013 executed between Executive Officer Municipal Committee Kathua and World Sanitation Environment for construction and maintenance of public toilets at various places in Kathua for public use for a period of 30 years without any tenders or without following any procedure.

The petitioner also sought direction to the State Vigilance Organization to register a case

under provisions of Corruption Act against the respondents for their illegal act of allotting the contract to private respondent.

Vacation Judge of High Court Justice BL Bhat, after hearing Senior Advocate Sunil Sethi with Advocate Veenu Gupta appearing for the petitioner, issued notice to Principal Secretary Housing and Urban Development Department, Director Local Bodies Jammu, Executive Officer Municipal Committee and World Sanitation Environment through its Chairman Dr P Jha returnable within one week.

In the meantime, subject to objections from other side and till next date before the Bench, the operation or order impugned was stayed and World Sanitation Environment through its Chairman Dr P Jha was restrained from executing the contract till next date of hearing.

Govt to bring bill to regulate medical equipment sector

NEW DELHI, June 20:

The Government will soon bring a Bill which is aimed at regulating the medical equipments industry in the county which so far has remained unregulated.

The new Bill will replace the existing Drugs and Cosmetics (Amendment) Bill, 2007 which is pending in Parliament and will have to be withdrawn.

Giving this information here today, Joint Secretary in the Health Ministry Arun Kumar Panda said regulation of medical devices industry has been a major challenge for the government and present thousands of such equipments are used in an unregulated manner.

The government will soon put up before the Cabinet the new bill which will have a separate chapter on medical devices, he said addressing a seminar -- 'Harnessing Medical Technology for inclusive health-care in India'.

The Bill provides for monitoring and setting standards for medical devices. The Bill, if passed, will help strengthen the domestic manufacturing industry and could make medical devices more accessible and affordable to the people at large in the country.

Panda said India's pharmaceutical sector has made rapid strides in the last few years and "we still need to create a place of our own in the medical devices sector".

He said the Government is keen on strengthening its regulatory body - Central Drugs Standard Control Organisation - by providing more skilled manpower and better infrastructure in its offices across the country.

For that, the government has already allocated Rs 1800 crore at national level during the current 12th five year plan and Rs 1200 crores to the states for the same. (PTI)

Turkey seeks India's cooperation in tourism, R&D to boost trade

NEW DELHI, June 20:

Turkey today sought enhancing cooperation with India in areas like research and development, tourism and manufacturing to boost trade and economic ties between the countries.

Turkey Ambassador to India Burak Akcapar said that a new and liberalised trade framework is required for both the countries.

"There is a need to bring business communities of the two sides together in order to explore opportunities in other nations. Both India and Turkey are lagging in R&D, so a collabora-

tive scheme is required," he said at a Federation of Indian Export organisations (FIEO) function.

He also advocated for more flight operations between the nations to increase tourist traffic as the existing flights are inadequate to cope with the demand.

"There is a huge potential in tourism sector cooperation. Increasing flight operations would help India to attract more and more foreign tourists," he said.

Turkey is an important inbound tourist source market for India. In 2011, a total number of 17,329 tourists from Turkey visited India.

Turkish Airlines is planning to spread their network in India with the possible code sharing with Air India, Akcapar said.

Addressing exporter members of FIEO, he said that the bilateral trade between the countries are below potential.

"More and more business-to-business meetings should be arranged to increase interactions between the companies of both the sides," he added.

The bilateral trade stood at about USD 5 billion in 2012-13. (PTI)
