Release 5 months wages of DD casual labourers: INTUC

JAMMU, June 22: Senior INTUC leader P N Pandita has expressed grave concern over non disbursement of wages of casual labourers of Dooradshan Jammu for last five months.

In a statement issued today he urged the Prasar Bharti authorities to take immediate steps in releasing the wages of the casual labourers as they are at the verge of starvation.

Mr Pandita has also made an appeal to Union Minister of Broadcasting to look into the problem and issue directives to the authorities to pay wages to these hapless workers who have no other source of income.

He warned that in case authorities fail to release wages to these workers they will be forced to come to streets and INTUC will fully back them in this struggle.

100 persons rescued in Himachal Pradesh, toll reaches 24

SHIMLA, June 22: The State and IAF choppers today rescued 100 persons, including 16 foreigners, from Kaza and various parts of rain ravaged tribal district of Kinnaur even as the recovery of 10 bodies took the death toll to 24.

Six bodies of Nepali migrants, including two children, were recovered from the debris of a collapsed house at Lipa in Kinnaur, Superintendent of Police, Kinnaur, G Shiva Kumar, said.

Four bodies were found in Shimla and Sirmour districts. As per the reports from various parts of the State, 300 houses had collapsed while 150 heads of cattle perished. Seven foreigners from Tabo near Kaza in Spiti tribal area, seven from Nako and two from Pooh were among the 100 persons rescued today, sources said.(PTI)
