NEW DELHI, June 26: Chipmaker Intel today introduced 4th generation Intel core processors, which the company claims will reinvent personal computing with longer battery life, more advanced graphics and new usages in devices like tablets and ultrabooks.

"The 4th generation Intel core processors offer the most significant gain in battery life ever achieved by Intel, up to double graphics and significant CPU performance improvements," Intel South Asia Managing Director (Sales and Marketing Group) Debjani Ghosh said here.

The US-based firm's latest offering will also serve as the foundation for computing in two-in-one devices, which work as a PC and can also serve as a tablet, she said.
