- To ensure recording the correct 000 codes (allotted by District Fund Office Jammu to the Drawing and Disbursing Officers) and Computer Codes/Previous Account Numbers (allotted to each subscriber by District Fund office Jammu) at the time of presentation of Salary/ other arrear bills to the treasuries so that this office may not face any difficulty while posting the credits/debits of the subscribers in their respective accounts.
- To record a certificate on the consolidated withdrawal certificate to the effect that no GPF Advance has been drawn after the date of retirement/death of the ex-subscriber.
- To record the withdrawal certificate with T.V. No. and date of withdrawals on the face of GPF statement while its issuance to the subscribers so that they do not face any inconvenience at the time of settlement of F.R/T.E cases.
- To attach a copy of the last G.P.Fund Advance sanctioned in favour of the ex-subscribers before retirement /death while submitting the final G.P.Fund Refund case to the fund office for finalization.
- To adhere to the Rule 6-B of G.P.Fund Rules, according to which a subscriber shall have option either to subscribe or stop to subscribe to G.P.Fund account during the last one year of his service preceding the date of retirement.
