

Ordered probe of WhatsApp policy on competition aspect: CCI to HC

NEW DELHI, Apr 13: The high court which reserved its order in the matter was told by Lekhi that whether the data collection by WhatsApp and sharing it with Facebook would amount to an anti-competitive practice or abuse of dominant position can be determined only after the investigation.

He also said that the investigation ordered was only an administrative proceeding which did not have any civil consequence at this stage. (PTT)

The CCI was looking into the competition aspect and not the alleged violation of individuals' privacy which was being looked into by the Supreme Court, Lekhi said.

"There is no question of jurisdictional error," he said and added that WhatsApp and Facebook's pleas challenging the CCI's decision were "incompetent and misconceived".

WhatsApp and Facebook, represented by senior advocates Harish Salve and Mukul Rohatgi, have challenged the CCI's March 24 order directing a probe into the new privacy policy.
