Subject: Additional list of candidates called for Counselling-cum-Documents Verification for various posts advertised vide Advertisement Notification No.03 of 2020 dated: 01.12.2020 (PM Package for Kashmiri Migrants & Non-Migrant Kashmiri Pandits)-regarding.

- Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) upon receipt of indent / requisition from Department of Disaster Management, Relief and Rehabilitation, advertised 1997 posts of various categories under PM Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits vide Notification No 03 of 2020 dated 01.12.2020; and,
2. Whereas, the Jammu and Kashmir Services Selection Board (JKSSB), conducted Computer Based Written Test (CBT) examination for posts advertised vide aforesaid notification from 29th March, 2021 to 05th of April 2021 in multi sessions/slots; and,
3. Whereas, the result/score sheets for the said posts have been notified vide this office Notice No. SSB/Secy/Sel/2021/3556-64 dated 22-04-2021 on the basis of Percentile Score by using Normalization Procedure; and,
4. Whereas, the provisional shortlist of candidates for the said posts was notified vide this office Notice No. SSB/Secy/Sel/2021/3708-13 dated 30 .04.2021; and,
5. Whereas, due to surge in COVID-19 cases across the Union Territory of Jammu & Kashmir and rapidly changing circumstances, lockdown restrictions including social distancing norms and health considerations, the Jammu and Kashmir Services Selection Board (JKSSB) vide Notice No.SSB/Secy/Sel/2021/3820-30 Dated:18-05.2021, called candidates for Counselling-cum-Documents Verification through "Online Mode" in Phase-I; and,
6. Whereas, keeping in view the requirement, to fill all requisitioned vacancies /posts, Jammu and Kashmir Services Selection Board (JKSSB) decided to call additional candidates for Document Verification in 2nd Phase, vide Notice No.SSB/COE/Mig/2021/5280-89 Dated: 30.07.2021; and,
7. Whereas, in the meanwhile the JKSSB analysed the available data of candidates called for document verification in two phases as mentioned hereinabove, and observed that there is overwhelming repetition of candidates called for document verification in respect of advertised posts which may eventually lead to figuring of same candidates in select lists for the advertised posts and leave significant number

- of posts unfilled/vacant; and,
8. Whereas, the PM Special Package posts for Kashmiri Migrants and Non-Migrant Kashmiri pandits, were initially referred to the Jammu and Kashmir Services Selection Board in the year 2012. The selection process was initiated & completed in the year 2017. However, sizeable number of posts remained unfilled due to non-availability of eligible candidates which were returned to the aforesaid Indenting Department in 2017. Subsequently, the said department again requisitioned 1997 unfilled vacancies for making appointment in October, 2020; and,
9. Whereas, the process of conducting written test examinations for the purpose of selection is a tedious one, for which massive arrangements are put in place including mobilisation of men & machinery for ensuring transparency, fairness & integrity. Besides the candidates also put in lot of hard work and undergo stress & struggle while preparing for scheduled competitive examinations; and
10. Whereas, unfilled posts / vacancies cause frustration amongst candidates who get deprived of employment opportunity due to figuring of same candidates in multiple Select Lists and therefore, it would be fit & appropriate to make concerted endeavour not to leave any post/vacancy unfilled; and,
11. Whereas, the JKSSB examined all related aspects and considered the requirement to fill all requisitioned vacancies /posts for various cadres and accordingly decided to call additional candidates for 3rd phase of Counselling-cum-Documents Verification for the following posts:
a. Field Assistant III
b. Field Supervisor Mushroom
c. Assistant Store Keeper
12. Accordingly, the candidates figuring in Annexure "A", "B" and "C" to this notice are hereby called for Counselling Cum Document Verification as keeping in view the Percentile Score acquired by them in the CBT examination. It may be noted that the candidates called for documents verification shall not have entitlement/claim to his/her inclusion in the final selection list, simply on the ground of figuring in the annexed lists.
a) The candidates figuring in the aforesaid Annexures shall have to appear before the Counselling Cum Document Verification Committee, on the dates shown against each with the following documents in original: -
• Copy of Online Application form.
• D.O.B Certificate.
• Reserved Category certificate, if applicable.
• Domicile Certificate.
• Other documents as per the advertisement.
• Bonafide certificate on the format prescribed by the Board duly issued by the Controller /Registrar of the concerned University in respect of candidates, who have obtained degrees from the Universities/ Colleges outside the State of J&K, other than Central Universities.
The Candidates are figuring in Reserved Categories, purely on the basis of details they have incorporated in their data i.e., online application form. Their respective claims on this account are further subject to production of valid Reserve Category certificate at the time of Counselling-cum-Documents Verification, in addition to the normal process of verification indicated at para 12(a) hereinabove.
