- 1) That the contract shall be for a period of one year from the date of execution of contract agreement.
- 2) The maximum annual contract amount has been fixed as Rs. 1.80 Lac.
- 3) The CDR/DD for an amount of Rs. 4500/- shall be attached with the quotation as Earnest money.
- 4) Any quote without Earnest money shall be out rightly rejected.
- 5) That the contractor shall be liable to maintain the other prominent places of worship (Eidgahs) and Ziarats under the control of Auqaf Jammu in the same contract amount.
- 6) That the quoted amount shall be inclusive of all taxes, if any.
- 7) That the payment shall be released on monthly basis on or before 10th day of each month subject to the satisfactory report by the concerned Field Inspector/Jr. Er.
- 8) That the contractor can leave the job by an advance notice of 15 days, so that an alternate arrangement is made with forfeiture of the earnest money.
- 9) In case the contract is terminated by the department, you shall be entitled to take refund of the earnest money.
