

India’s recovery rate at 96.7%

NEW DELHI, Jan 20: With 13,823 infections reported in a day, India's COVID-19 caseload rose to 1,05,95,660, while the recoveries surged to 1,02,45,741, the Union Health Ministry said today.

The death toll due to the disease increased to 1,52,718 in the country as 162 new fatalities were recorded, the Ministry data updated at 8 am showed.

The total number of people who have recuperated from the disease surged to 1,02,45,741, pushing the national COVID-19 recovery rate to 96.70 per cent.

The COVID-19 case fatality rate stands at 1.44 per cent, it said.

The active caseload remained below 3 lakh. There are 1,97,201 active coronavirus infections in the country, which comprises 1.86 per cent of the total caseload, the data stated.

India's COVID-19 tally had crossed the 20 lakh-mark on August 7, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on September 16. It went past 60 lakh on September 28, 70 lakh on October 11, 80 lakh

Addressing a press conference here, Senior Superintendent of Police Kanwardeep Kaur said the accused were to deliver the consignment in Delhi.

All the accused were residents of Kashmir, said the police.

During preliminary interrogation, they confessed having delivered more than 10 kilogram of heroin in the past, the police claimed.(PTI)
