WHEREAS, on the recommendations of the J&K Public Service Commission, sanction was accorded, vide Government Order No. 56-JK(HME) of 2021 dated 22-01-2021, to the temporary appointment of one hundred fifty three (153) candidates as Medical Officers in the Jammu and Kashmir Health and Family Welfare (Gazetted) Service in the pay scale Level-9 (52700-166700), along with their postings, subject to fulfillment of various conditions including following condition:-

“C) The appointee(s) shall submit their joining reports physically to their concerned Drawing and Disbursing Officers(DDOs) within a period of 21 days from the date of issuance of this order and in case of failure of any appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.”

AND WHEREAS, in the aforesaid Government Order No. 56-JK(HME) of 2021 dated 22-01-2021, it was further ordered that:-

“All the concerned Drawing & Disbursing Officers of Health & Family Welfare Department shall submit categoric report/details of appointees who fail to join physically within the stipulated time period immediately after expiry of 21 days to the Administrative Department through concerned Directorates. Besides, attendance alongwith documentary evidence in respect of the appointees, who joined physically, shall be submitted at the end of every month to the Administrative Department through concerned Directorates and in case any discrepancy of facts is brought to the notice of Administrative Department, action as warranted under rules, shall be taken against such DDO(s).”

AND WHEREAS, the H&ME Department vide communication No. HD/Gaz/Gen/153/2020-I dated 12-02-2021 requested Director, Health Services, Kashmir/Jammu to furnish the details of all such Medical Officers (Appointees) who have physically joined/ not-joined, as per prescribed Proforma-I and Proforma-II duly authenticated by the concerned DDO in a consolidated statement;

AND WHEREAS, the Director, Health Services, Kashmir vide communication No: Est-3/1-133/3471 dated 17-02-2021 & Director, Health Services, Jammu vide communication No. DHSJ/ES-3/56-JK(HME)3689 dated 15-02-2021 furnished the information/particulars of 90 Medical Officers (appointees) (24 from Kashmir Province & 66 from Jammu Province), who have not joined at their respective place of postings upto the last date of joining i.e. 12.02.2021.

Now, therefore, it is hereby ordered that the appointment in respect of 90 Medical Officers, appointed vide Government Order No. 56-JK(HME) of 2021 dated 22-01-2021, as indicated in **Annexure-A (Pages 1-7)** to this order, shall be deemed to have been cancelled, ab-initio for their failure to join within prescribed period of time.
