Example:- In a semester of 22 credits the 50% value comes out to be 11 but for the purpose of eligibility for admissions only 10 credits are required.
2. Should be vaccinated in case the age of applicant is more than 18 years.
3. Should have filed an on line anti ragging affidavit at https://amanmovement.org/registration/public/amanmovement/Affidavit.php

New Delhi, the 12th October, 2021

S.O. 4217(E).—In exercise of powers conferred by sub-section (1) of section 3A of the National Highways Act, 1956 (48 of 1956) (hereinafter referred to as the said Act), the Central Government, after being satisfied that for the public purpose, the land, the brief description of which is given in the Schedule below, is required for building (widening two lane with paved shoulder/four laneing etc.), maintenance, management and operation of NH 144A in the stretch of land from Km. 0 to Km. 0.8 (Deputy Commissioner office, wazarat Road, Jammu), in the district of JAMMU in the Union Territory of JAMMU & KASHMIR, hereby declares its intention to acquire such land.

Any person interested in the said land may, within twenty-one days from the date of publication of this notification in the Official Gazette, object to the use of such land for the aforesaid purpose under sub-section (1) of section 3C of the said Act.

Every such objection shall be made to the Competent Authority, namely, Deputy Commissioner, Jammu in writing and shall set out the grounds thereof and the Competent Authority shall give the objector an opportunity of being heard, either in person or by a legal practitioner, and may, after hearing all such objections and after making such further enquiry, if any, as the Competent Authority thinks necessary, by order, either allow or disallow the objections.

Any order made by the Competent Authority under sub-section (2) of section 3C of the said Act shall be final.

The land plans and other details of the land to be acquired under their notification are available and can be inspected by the interested person at the aforesaid office of the Competent Authority.

Subject: -Last and Final opportunity---Notice thereof.

Whereas, you had proceeded on earned leave w.e.f. 14.11.2015 to 12.01.2016 & got it extended w.e.f. 13.01.2016 to 03.02.2016 and after end of leave neither you extended the leave nor joined the department, and;

Whereas, consequently, an explanation was called by the State Malarologist, J&K, Jammu, vide No:-SMJ/ 1502-03, dated 05-02-2016, directing you to join your duties otherwise disciplinary action under rules shall be initiated against you, and;

Whereas, despite of explanation call you did not join as such a Notice No. I was issued by the State Malarologist, J&K, Jammu, vide No:- SMJ/1565-67, dated 16-02-2016, for remaining absent from duty un-authorizedly, which was also got published in the News paper Punjab Kesri in its edition dated 20.02.2016, whereunder you were directed to join your duties in the department immediately otherwise action as warranted under rules shall be initiated against you, and;

Whereas, consequently, a communication/application for extension of leave was received on 10-03-2016, which apparently was not signed by you as the signatures did not tally, whereunder you requested to extend the leave without mentioning the period of extension, taking the grounds of your bad health, without attaching any medical record to its evidence, and;

Whereas, your leave had not been extended and you were absent from your legitimate duties unauthorisedly as such another Notice No:-II was issued by the State Malarologist, J&K, Jammu, vide No:-SMJ/ 1840-42, dated 18-03-2016, which was also got published in the News Paper Danik Jagran in its edition dated 26-03-2016, directing you to join duties. In . response thereof, you again vide communication/application dated 09-04-2016, which again was not signed by you, requested to extend the leave, again without mentioning the period of extension, taking the same grounds of bad health, without attaching any medical record as evidence, and;

Whereas, the State Malarologist, J&K, Jammu, vide communication No:-SMJ/81-82, dated 21-04-2016 followed by another communication No:- SMJ/208-09, dated 12-05-2016, directed you to produce the medical record/reports to substantiate your bad health. But despite of these communications, you failed to produce any medical record of your illness, and;

Whereas, vide No:-SMJ/555-57, dated 22-07-2016, you were issued a Notice to Show Cause as to why your services may not be terminated for remaining absent from duties unauthorisedly. Through this Show Cause Notice you were asked to furnish your reply within ten days positively otherwise action as warranted under rules shall follow. However, neither had you submitted any reply to the Show Cause Notice nor you joined the duties till date.

Whereas, under Article 128 of CSR Vol-I, absence without leave or after the end of leave involves loss of appointment and Article 113 of CSR Vol-I, provides that after five years continuous absence on leave, an officer is considered to be out of state employ.

Now, therefore, you are hereby given last and final opportunity of five days to join the department otherwise your services shall be terminated without any further notice.
