Whereas, vide Order No: 25-JKRCW of 2018 dated: 20-08-2018 the One Stop Centre for Women in respect of Kathua district was outsourced to bidder M/s Perfect Education Club, Kathua which was subject to signing of MOU with District Administration as per terms and conditions but the MOU was never signed; and

Whereas, State Mission Director, SRCW vide Order No: 126 SMD JKRCW-2021 dated 29-03-2021 issued under endorsement No: JKRCW/86/2018 dated: 29-03-2021 issued the 'Cancellation Order for running of One Stop Centre for Women, Kathua to 'Perfect Education Club'; and

Whereas, vide Order No: 127 SMD JKRCW of 2021 dated 15-04-2021 issued vide endorsement No: JKRCW/86/2018 dated 15-04-2021, Sanction was accorded for assigning additional charge to the officials from Integrated Child Protection Services posted in district Kathua for the operationalization of One Stop Centre (Sakhi Centre) Kathua; and

Whereas, Perfect Education Club moved to Hon'ble High Court (WP(C) no. 728/2021 & CM No. 3227/2021) and Hon'ble High Court issued interim directions as follows, 'In the meanwhile, till next date of hearing, operation of the order impugned shall stay subject to the condition that no complaints are pending against the petitioner'

Whereas, as per guidelines, initial engagement of any NGO for running the One Stop Centre was for one year and further extension shall be subject to performance of NGO and more than three years has passed since State Mission Director, State Resource Centre for Women Social Welfare Department outsourced to bidder M/s Perfect Education Club, Kathua which was subject to signing of MOU with certain terms & conditions and no further extension was never extended; and

Whereas, One Stop Centre, Kathua is not functioning properly as it is not able to engage any staff/NGO or utilize funds available for running of 'One Stop Centre' and not able to provide desired assistance to women in distress/in need in line with the Hon'ble Supreme Court and Hon'ble High Court Judgments/directions issued from time to time; and

Whereas, Commissioner Secretary, Social Welfare Department, J&K in a meeting held on dated 02-03-2022, gave directions for making One Stop Centre functional in district Kathua; and

Whereas, Deputy Commissioner, Kathua being the Chairperson of Management Committee of OSC ordered to engage staff/providers for running One Stop Centre for women in district Kathua purely on contractual basis, as an interim arrangement to make OSC functional immediately and subject to final/interim judgment of Hon'ble High Court in WP(C) no. 728/2021 & CM No. 3227/2021.

- 1. Applicant must be Domicile of Jammu & Kashmir and resident of District Kathua.
2. Applicants should be medically fit for field visits in different blocks/villages of district Kathua.
3. Period less than one year (12 months) shall not be considered as first year of experience, however period of nine months in case of additional year of experience can be considered as one year.
4. Candidates will be shortlisted purely on Academic/Qualification merit basis (Pro-rata basis) whereas Viva-Voce will be considered in the final selection of the candidates.
5. The number of applicant for the viva voce shall be short listed in the ratio of 1 is to 5 on pro rata basis.
6. Being a temporary contract agreement, it is terminable from either side by one month with advance notice.
7. There shall be no right to seek permanent absorption in any department or regularization of any sort (agreement for the same sworn before Judicial Magistrate First Class, needed to be executed upon selection before joining).
8. Last date of receipt of application forms shall be cut off date of determining the eligibility to apply for the post. The age limit however is determinable with reference to the 1st of Jan of the year in which the Advertisement is made i.e. 01-01-2022.
9. The candidates called for interview must produce the original documents before the committee constituted for oral test so that their eligibility for participation in the interview is verified. Any candidate who fails to produce the relevant original documents/testimonials shall not be allowed to appear in the Viva voce. A photocopy each such duly self attested and signed by the candidate should be brought along with him/her for depositing the same in the office.
10. If a candidate is found guilty of impersonation or submitting fabricated/tempered documents/testimonial or making statements which are incorrect or false or suppressing material information at any stage of the selection process, his/her candidature shall be deemed to be void ab-initio.
11. The candidates must possess the minimum requisite qualification at the time of submitting the form.
