

KVIC clocks Rs 1.15 lakh cr turnover in FY22

NEW DELHI, Apr 30:

The Khadi and Village Industries Commission (KVIC) achieved a whopping Rs 1.15 lakh crore turnover in 2021-22, growing at a rate of 20.54 per cent from the previous year, the Government said on Saturday.

The MSME ministry stated that KVIC has achieved a height which remains a distant goal for all FMCG companies in India.

"Thanks to the constant support of Prime Minister Narendra Modi, KVIC has, for the first time, clocked a massive turnover of Rs 1.15 lakh crore, which is unprecedented by any FMCG company in the country. This makes KVIC the only company in the country to have recorded a turnover of Rs 1 lakh crore," the statement said. (PTI)
