2. Bidder shall provide Bid Security Certificate.
3. After opening of the tender if the rates quoted by the lowest bidder are found to be high & value of work more than the advertised cost, he/she is advised to negotiate his/her quoted rates with the department/offer his/her consent within five days after opening of the tenders, failing which the work shall be put to fresh tender.
