## Railways remove PSU CMD

NEW DELHI, Oct 17:

The Railways has removed the chairman and managing director of its PSU Indian Rail Finance Corporation (IRFC), Amitabh Banerjee, over alleged financial misconduct and misuse of position, officials said on Monday.

The development came days after the Government sacked National High Speed Rail Corporation Limited MD Satish Agnihotri over corruption allegations.

IRFC is a public sector undertaking (PSU) owned by the Railways which lends money to the national transporter for purchase of rolling stock and, of late, creation of infrastructure assets.

Sources said Banerjee was given a vigilance clearance by the Railways in October 2020, allegedly without taking into account that the CBI had by then named him in an FIR about a multi-crore case of financial bungling at another PSU where he had earlier worked.(PTI)
