Hindu girl not allowed to leave shelter home by Pak court

KARACHI, Oct 27: A Pakistani court today did not allow a Hindu girl to leave a shelter home and go with her parents despite medical tests confirming that she was 16 years old when forcibly abducted, converted to Islam and married to her abductor, in Pakistan's Sindh province. The girl was abducted two months ago from Sindh's Hyderabad city and was recovered and sent to a safe home on October 20 after a court ruling. The court ordered a medical examination to determine the girl's age as her alleged husband submitted a marriage certificate showing that she was 19 years of age. But medical tests confirmed she was 16 years old and underage. The court ruled today that the girl will remain in a shelter home under the supervision of the local administration until the next hearing on October 31, as it needed to look further into the matter, much to the distraught of her parents.
