# Chandrayaan-3 completes last Moon-bound manoeuvres

BENGALURU, Aug 16: India's ambitious Chandrayaan-3 spacecraft on Wednesday successfully underwent a fifth and final lunar-bound orbit manoeuvre, bringing it even closer to the surface of the Moon. With this, the spacecraft has completed all of its Moon-bound manoeuvres, and it will now prepare for separation of the lander module - comprising the lander and rover - from the propulsion module. "Today's successful firing, needed for a short duration, has put Chandrayaan-3 into an orbit of 153 km x 163 km, as intended. With this, the lunar bound manoeuvres are completed. It's time for preparations as the Propulsion Module and the Lander Module gear up for their separate journeys," ISRO said in a post on X (formerly Twitter). Separation of the lander module from the propulsion module is planned for August 17, it said. Post its launch on July 14, India's third Moon mission Chandrayaan-3 entered into the lunar orbit on August 5, following which orbit reduction manoeuvres were carried out on August 6, 9 and 14. As the mission progressed, a series of manoeuvres were being conducted by ISRO to gradually reduce Chandrayaan-3's orbit and position it over the lunar poles. After separation, the lander is expected to undergo a "deboost" (the process of slowing down) to place it in an orbit, where the Perilune (closest point to the Moon) is 30 kilometres and Apolune (farthest point from the Moon) is 100 km, from where the soft landing on the south polar region of the Moon will be attempted on August 23, ISRO sources said. ISRO Chairman S Somanath recently said the most critical part of the landing is the process of bringing the velocity of the lander from 30 km height to the final landing, and that the ability to transfer the spacecraft from horizontal to vertical direction is the "trick we have to play" here. "The velocity at the starting of the landing process is almost 1.68 km per second, but this speed is horizontal to the surface of the moon. The Chandrayaan-3 here is tilted almost 90 degrees, it has to become vertical. So, this whole process of turning from horizontal to vertical is a very interesting calculation mathematically. We have done a lot of simulations. It is here where we had the problem last time (Chandrayaan-2)," Somanath explained.(PTI)

The candidates are advised to report to the respective allotted Colleges / Institutions w.e.f 16.08.2023 to 22.08-2023 till 04.00 p.m. along-with the following documents in original: -

- 1) Date of Birth Certificate (Matriculation Diploma/10th class marks card).
- 2) Marks Card of 10+2 (with PCM or PCB)
- 3) Domicile Certificate.
- 4) Category Certificate, if any applicable.
- 5) Any other document as may be required by the concerned college authorities.

The candidates, who have been allotted Government /Private Colleges, shall have to mandatory join against their provisionally allotted College/Seat(s) upto 22.08. 2023 till 04.00 p.m positively and in case any candidate(s) fails to join against his/her allotted seat(s) shall not be eligible to participate in the 2nd Round of counseling for up-gradation /allotment under any circumstances.

It shall be the sole responsibility of the concerned College / Institution to ensure proper check and verification of the documents/eligibility before the candidate(s) is allowed for admission strictly as per the Pharmacy Council of India (PCI) guidelines.

After the last date of joining, the unfilled seat(s), alongwith the shortfall, if any, shall be communicated to the Board by the concerned College(s)/ Institutions in the shape of hard copy duly signed by the concerned Heads of the College / Institutions on 23.08.2023 upto 12.00 Noon positively, so that these unfilled/vacant seats shall be filled up during the 2nd round of counseling for which the date(s) shall be notified separately.

The Heads of the Colleges/Institutions shall keep open the admission counters of their respective Institutions during the Holidays if any including Sundays falling up to 22.08.2023.

**Note:**

- 1) The admission of the candidates is purely provisional and shall be liable to be cancelled in case any information furnished by any candidate proves to be false/ fabricated, and action as warranted under law shall be initiated against such candidates; and
- 2) It is hereby implored upon the management of all Colleges/ Institutions to ensure the veracity of documents, particularly the Category Certificates wherever the admission is to be granted in lieu of a particular Reserved Category; and
- 3) The Persons with Disability, if any, selected in Open Merit or against a Reserved Category, it shall be ensured that his/her PwD Certificate/eligibility is in conformity with PCI guidelines / regulations framed by the concerned Regulatory Authority & wherever required shall refer the matter to concerned Medical Board to assess such candidates and make recommendations based on which Institution shall take further necessary action.
