Sub: Suspension/Cancellation of Registration of
vehicle hearing Registration No:JK06- 6734 found
indulged in the illegal transportation of Bovine ani-
mals & cruelty to the animals

Whereas, your vehicle bearing Registration No.
JK06-6734 (Bolero Camper Pickup ) was found
indulged in the illegal transportation of Bovine
Animals in the District Doda and case stands reg-
istered against the defaulters by the Disit. Police in
the Police Station. Doda under FIR No. 136/2022
U/S 188/IPC,11/PC Act Dt. 26-06-2022. as per the
communication No. CRB/Bovine-2022/53729-38
Dated: 08-12-2022 received from the Sr.
Superintendent of Police, Doda.

Whereas, the Sr. Superintendent of Police, Doda has
felt imperative to take stem action against the
defaulters and it has been recommended by the Sr.
Superintendent of Police, Doda. that the Registration

certificate & Permit of the above said vehicle be can-
celled at an earliest under intimation to their office
and:

Whereas. according to Rule 125-E (Special
Requirement of Motor vehicles Transporting live-
stock) of the Central Motor Vehicles (Eleventh
Amendment) Rules. 2015. Motor vehicle should be in
accordance with the specification of the Bureau of
Indian Standard as provided in IS-14904: 2007; or IS-
5238: 2001: OR IS-5236:1982 and also the trans-
portation of live animals governed by the Rules pre-
scribed for the purpose and;

Whereas. in the event of contravention or non com-
pliance of any of rules contained in the rules pre-
scribed for the transportation of the live animals and
if it is pointed out by any officer or persons. then any
permit or authorization issued such transport shall be
immediately cancelled by the concerned authority and:

Whereas, according to sub section 1 of section 86 of
Motor Vehicles (Amended) Act. 2019: The Transport
authority which granted a permit may cancel the per-
mit or may suspend it for such period as it thinks fit.

Whereas, if any Registering authority or other pre-
scribed authority has reason to believe that any
Motor Vehicle within its jurisdiction:

(a) Is in such a condition that its use in a public place
would constitute a danger to the public, or that it fails
to comply with the requirements of this Act or of the

rules made thereunder or

(b) Has been, or is being used for hire or reward with-
out a valid permit for being used as such, the
Registering authority is empowered to suspend the
certificate of the Registration;

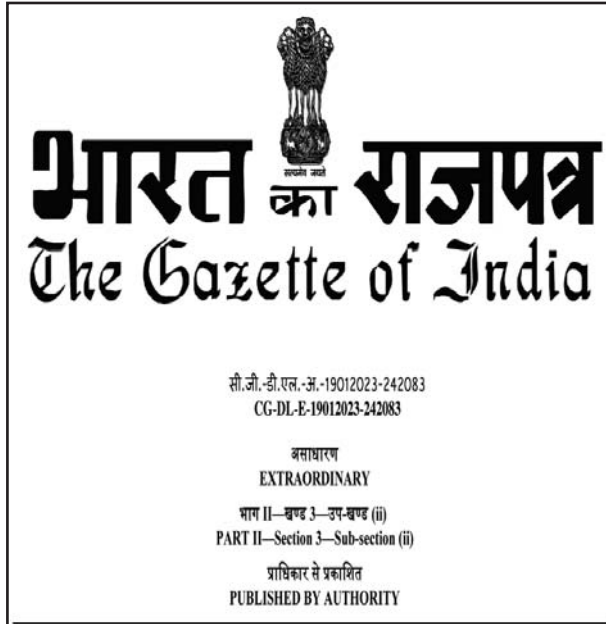
In view of above facts & circumstances of case and
sheer violations/contravention, of all the above cited
provisions of the Motor Vehicle Act & Rules and rules
framed for transportation of Bovine animals in the
above said vehicle which stands registered in your
name & the involvement and prima-facie use of
Motor vehicle for the commitment of offences and
illegal action referred to herein.

The show cause notice is hereby issued to you to
explain your position (to give you hearing to ensure
natural justice) why the Registration Certificate
should not be cancelled for indulging in illegal trans-
portation of Bovine animals and cruelty to animals.
The reply of "Show Cause Notice" should reach this
office along with Registration Certificate of the said
vehicle within 10 days from the date of issuance of
this notice, otherwise it shall be presumed that you
have nothing to say in your defense and the action as
warranted under Law shall be initiated.

ED cases fake, are used to
topple or form Govts: Kejriwal

NEW DELHI, Feb 2: This is the real face of
Kejriwal and his Aam Aadmi
Party (AAP), he said, citing the
ED charge sheet.
"Indulgence in corruption by
Kejriwal and use of money paid
by liquor mafia was perhaps a
sin that caused the defeat of
AAP in the Goa elections and
the Delhi people will not forgive
them for it," he said.
In its charge sheet, the ED
has alleged that a close aide of
Kejriwal received kickbacks to
the tune of Rs 100 crore from a
group, on behalf of AAP lead-
ers.
"Investigation of the trail of
this kickback so far has revealed
that part of these funds were
used in the election campaign of
the AAP for Goa assembly elec-
tions 2022. Cash payments to
the tune of Rs 70 lakh were
made to the volunteers who
were part of the survey teams,"
the ED said.
The court took cognisance
of the supplementary charge
sheet filed by the ED against
five individuals and seven com-
panies in connection with
alleged irregularities in the
Delhi excise policy, which was
withdrawn last year by the AAP
government after a CBI probe
video asked liquor mafia to pay
Rs 100 crore to Nair." BJP MP
Manoj Tiwari alleged.
