Attention Banquet Hall Owners

Sub: Last and Final Notice under Environmental Laws.

Whereas, no Banquet Hall can be established/operate, without prior consent of the Pollution Control Committee, as warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively.

Whereas, the Banquet Halls falls in Orange category as per Uniform Consent Mechanism and it is obligatory for all the Banquet Hall Owners to obtain mandatory consent from the J&K Pollution Control Committee for carrying out such activity.

Whereas, banquet halls are required to meet the effluent/sewage standards prescribed under Environment (Protection) Act 1986 by installing STP of required capacity in the Banquet Hall.

Whereas, guidelines issued by the J&K Pollution Control Board (now as Committee) in this regard vide No. SPCB/LS/Banquet Hall/109/2009/2196-07 dt. 07-12-2009 has been circulated to all stake holders

Whereas, the Hon'ble National Green Tribunal (NGT) vide its order dt. 17-12-2019 in O.A. No. 400/2017 has directed that no Banquet Hall be allowed to operate without meeting environmental norms and having consent from the Pollution Control Board/Committee.

Now therefore, by virtue of this last and final Notice, it is hereby once again enjoined that all the Banquet Hall Owners of J&K Union Territory are directed to obtain mandatory consent from the J&K Pollution Control Committee by or before 15th of April, 2023 failing which closure of defaulting Banquet Halls will be initiated without giving further notice as warranted under rules.

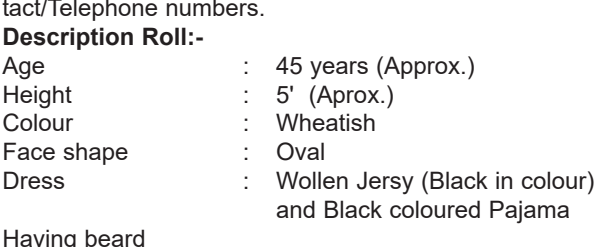

Pak police breach former premier Imran Khan's Lahore residence; recovers weapons, petrol bombs

LAHORE, Mar 18: Islamabad to appear before a court hearing a corruption case against him.

The police launched the "grand operation" at Khan's Zaman Park residence here and removed all camps, and barricades erected there by Pakistan Tehreek-e-Insaf (PTI) party activists to prevent his arrest in the Toshakhana case.

The 70-year-old PTI chief has been in the crosshairs for buying gifts, including an expensive Graff wristwatch he had received as the premier at a discounted price from the state depository called Toshakhana, and selling them for profit.

During the operation, 61 workers of the Pakistan Tehreek-e-Insaf party were arrested and about 10 PTI workers and three policemen were injured.

Over 10,000 armed Punjab police personnel launched a major operation at former Pakistan Prime Minister Imran Khan's residence here and arrested dozens of workers of his party and claimed to have seized weapons and petrol bombs, hours after he left for

Khan's residence remained a battlefield between his party workers and police and Rangers for two days earlier this week over his "arrest operation" in the case.

The PTI workers however succeeded in foiling his arrest attempt and the operation was halted on the Lahore High Court's order earlier this week.

Inspector General Police Punjab Dr. Usman Anwar after the operation told a press conference that earlier the police had stopped the operation at Zaman Park on LHC order and PSL match.

"However, the court didn't stop us from taking action against those involved in attacking police. Today we launched an operation at 12 noon. We faced resistance from the PTI workers however we managed to control the situation and arrested 61 workers," he said.(PTI)

Trainer aircraft crashes in MP; two pilots missing

BALAGHAT (MP), Mar 18: An aircraft with two trainee pilots on board crashed in Madhya Pradesh's Balaghat district on Saturday, police said.

The charred body of a man was found in the mountains of Lanji and Kirnapur areas, about 40 km from the Balaghat district headquarters, near the crash site, Superintendent of Police Sameer Saurabh said this evening.

He said efforts are on to identify the body while a search is on for the woman trainee pilot who is missing.

As per the preliminary information, the trainer aircraft had taken off from the Birsi airport in Gondia district of Maharashtra bordering Balaghat, the police officer said.
