Active COVID case rise to 7,927
NEW DELHI, Mar 24:
India logged 1,249 new coronavirus cases, while the active cases have increased to 7,927, according to the Union Health Ministry data updated today.
The death toll has increased to 5,30,818 with one death each reported by Karnataka and Gujarat, the data updated at 8 am stated.
The daily positivity was recorded at 1.19 per cent while the weekly positivity was pegged at 1.14 per cent.
The Covid case tally was recorded at 4.47 crore (4,47,00,667).
The active cases now comprise 0.02 per cent of the total infections, while the national COVID-19 recovery rate has been recorded at 98.79 per cent, the Ministry said.
As many as 92.07 crore tests for detection of Covid have been conducted so far with 1,05,316 tests being conducted in the last 24 hours.
The number of people who have recuperated from the disease surged to 4,41,61,922, while the case fatality rate was recorded at 1.19 per cent.
According to the Ministry's website, 220.65 crore doses of Covid vaccine have been administered in the country so far under the nationwide vaccination drive. (PTI)

6 pro-separatists forcibly removed from NPC in US
WASHINGTON, Mar 24:
Six separatist loyalists were forcibly removed from the National Press Club here in the US capital after they repeatedly disrupted a panel discussion on Kashmir.
The panel discussion titled 'Kashmir: From Turmoil to Transformation' was held on Thursday. It was moderated by columnist Se Hoon Kim and addressed by president of the Jammu and Kashmir Workers Party Mir Junaid, and Touseef Raina, president of the Municipal Council of Baramulla.
"The whole audience has seen your real face today. What we have seen in Kashmir, we saw in Washington today, and thank you for showing the world how cruel, and indecent these people are. You have seen it all," Junaid said as the separatist sympathisers were taken out of the room.
They tried to disrupt the discussion while Junaid was responding to a question on the reasons why the Kashmiri Hurriyat leaders were in jail.
"They (Hurriyat leaders) are in jail because of their mistakes. They misled the people of Jammu Kashmir for their vested interests and gains. They spoiled our ecosystem of education. They were the spoilers of our economy. They were glorifying terrorism. They are in jail for their hate speech. They are in jail for their war crimes," Junaid said.
Referring to the disruption caused by the protestors, Raina said all these years this is what the separatists sponsored by Pakistan have been doing in Jammu and Kashmir.
"What these gentlemen did, the same thing they did in Kashmir. Whosoever was speaking, right or for the people, was silenced by the gun," he said. (PTI)

Two allegedly commit suicide

JAMMU, Mar 24: At least two people allegedly committed suicides in Jammu province, police said today.
A police spokesperson said one Sonia (15) daughter of Vipan Kumar of Gurha, Billawar, Kathua, consumed some poisonous substance at her home today.
"After preliminary treatment, she was admitted in Government Medical College and Hospital (GMC&H) Jammu, where she breathed her last today," he said.
Meanwhile, at Parladpur Mandal area falling under the jurisdiction of Police Post Phallain Mandal, one Dhruv Kumar (21) son of Vasudev of Bihar, was found hanging at his home.
"He was also taken to GMC&H Jammu today where he didn't respond to the treatment," the police spokesperson said.
"Bodies of the deceased have been shifted to the mortuary of the hospital for conducting post-mortem while cases under relevant sections of the law stand registered at concerned police station," he added.
