## Dalai Lama names Mongolian boy as spiritual leader

Khalkha Jetsun Dhampa Rinpoche's reincarnation during his visit to Mongolia a few years ago in 2016. The Mongolian boy named as the 10th Khalkha Jetsun Dhampa Rinpoche had visited Dharamshala along with a group of Mongolian devotees and attended the teachings of the Dalai Lama and preliminary Chakrasamvara empowerment on March 8-9, 2023. The Office of the Dalai Lama in early this March released a photograph of the young boy Lama with a caption that read, "The reincarnation of Khalkha Jetsun Dhampa Rinpoche of Mongolia presenting traditional offerings to His Holiness the Dalai Lama at the start of the preliminary Chakrasamvara Empowerment at the main Tibetan temple in Dharamshala."

During the teachings, Dalai Lama said, "Khalkha Jetsun Rinpoche is here with us today. He came here to receive the Chakrasamvara empowerment, the previous Jetsun Dhambas practice mainly Chakrasamvara and it's an auspicious occasion.

The 9th Khalkha Jetsun Rinpoche was a Tibetan and he died in Mongolia in 2012. His family is now living in Dharamshala. His son Choephel Yonten runs a cafe in Mcleodganj. Choephel Yonten, said that they lived in Dharamshala but in 2009 they had gone to Mongolia and in 2012 his father, the 9th Khalkha Jetsun Rinpoche passed away in Mongolia.

He further said that he did not know much about the new reincarnated boy but, in 2016 His Holiness the Dalai Lama visited Mongolia and appointed or recognised him as the 10th Khalkha Jetsun Rinpoche. He said that the boy, the 10th Khalkha Jetsun Rinpoche visited Dharamshala along with a group of Mongolian Buddhist devotees for His Holiness' teachings on March 8-9, 2023.

Actually, the family of the 10th Khalkha Jetsun Rinpoche doesn't make any statement about the boy and they keep it secret.

He said that he did not know as to why they kept it as a secret. He suggested that there may be some political reasons behind it but expected that the things will become clearer in future.

The son of 9th Khalkha Jetsun Rinpoche said that as far as his enthronement ceremony is concerned, it didn't happen here yet, might have happened in Mongolia which he was not sure.

"I didn't hear anything about his enthronement. His Holiness the Dalai Lama briefly appointed him in 2016, nothing much officially but this time his Holiness the Dalai Lama said publicly that the 10th Khalkha Jetsun Rinpoche is here with us. So it's official now. Everybody knows about it and he is a very important Lama. All spiritual leaders like His Holiness the Dalai Lama or Khalkha Jetsun or Panchen Lama, we consider all of them equally respected."

On Tuesday, UNI contacted the Dalai Lama's office at Dharamshala which confirmed about this development. (UNI)

## Retail beer vends allowed at JKTDC/ Tourism establishments, Airports; bid starts from Apr 4

Transportation and maturation of bulk spirits. The Govt shall facilitate introduction of more BIO beer and other liquor brands by decreasing the import duty by Rs 5 per BL on beer and reduce the additional assessment duty on BIO brands by 50% over previous Excise Policy.

For the first time, a new country liquor brand of 45 degree proof has been introduced that is cheap and affordable and shall arrest/discourage sale of illicit liquor in the rural and semi urban areas and may prevent possible hooch tragedy.

For ensuring timely opening of JKEL-2 vends , for repeated premises there shall be no requirement of DMs clearance besides Deemed Clause introduced and renting out Government land for one year for opening vends where private premises is not available.

**With the declaration of new Excise Policy, 26 new JKEL-2 vends (22 in Jammu and 4 in Kashmir), total 305, have been proposed for retail sale of liquor in underserved and un-served areas of J&K UT. The fee has been revised as per the category of the hotels; fee /duty has been slightly changed for IMFL and JK Special Whisky.**

In order to discourage conflict of interest or monopolistic practices in liquor trade, all manufacturing units have been proposed to be declared as ineligible for grant of Type A,B, C Licenses.

The new Liquor vends have been proposed at Tourist places and places of illicit distillations with NOC from DM and a certificate from FSSAL. To address the grievances of stakeholders, quota transfer fee of Re 1 per bottle has been introduced for transferring MGQ from one vend to another. Promotion of digital payments have been encouraged. To ensure zero leakage, it has been proposed to install flow meters at Bottling Plants/ Distillers/Breweries.

Excise Commissioner, J&K, Pankaj Sharma said that the New Excise Policy has introduced many new progressive initiatives that will upscale revenue, will boost the local liquor industry with more incentives to optimize liquor production and also bring in more enforcements in regulation of liquor trade.

He disclosed that for encouraging informants, giving information about the growing / cultivation of poppy / cannabis, also manufacturing of illicit liquor and bootlegging, a new clause of rewarding the informers has been introduced in the policy. He added that all the services in the Excise department including liquor permits, duties, fee etc shall be provided only through online mode from e-Abqari Portal on real time basis.
